Dear Customer:

Kellogg is conducting a voluntary recall of certain retail grocery pack boxes skus of Corn Pops, Honey Smacks, Froot Loops and Apple Jacks cereals due to an uncharacteristic off-flavor and smell coming from the liner in the package. **Traditional single serve pack formats including cup, single serve individual boxes and bowls are NOT affected by this recall.** While the potential for serious health problems is low, some consumers are sensitive to the uncharacteristic off-taste and smell and should not eat the recalled products because of possible temporary symptoms, including nausea and diarrhea.

Only retail grocery pack products with the letters "KN" following the Better If Used Before Date are included in the recall. Products with a "KM" designation are NOT included in the recall.

To effectively execute this voluntary recall please follow the steps detailed below:

- 1.) Check warehouse inventory for the affected items.
- 2.) Locate products in your control, remove from inventory and destroy.
- 3.) Destroy product via a compactor or in a landfill. Obtain a witness signature.
- 4.) Complete the Wholesaler Product Disposition Form and fax to # 800-500-3698.
- 5.) The Kellogg credit process is deduction, to process your deduction Kellogg must receive the Product Disposition form completed and signed. Submit your deduction via the normal process.
- 6.) Immediately contact your customers that have purchased the impacted products and ask them to destroy it.
 - a. Please send these impacted customers the Press Release and the Retailer Product Disposition form for specific instructions.
